Alex,

As you are likely aware, John Snow served as U.S. Secretary of the Treasury from 2003 – 2006 prior to Hank Paulson. He is currently the Chairman of Cerberus Capital Management as well as holding a number of other senior board positions.

As you know Cerberus has been and continue to be particularly active in acquiring assets from Irish financial institutions.

(Dan Quayle, Chairman of Cerberus Global Investments, LLC, is another member of the Cerberus senior management team with whom the Minister met in September 2014 – pre meeting note attached.)

This would be a meeting the Minister would usually take and has taken in the past with similar institutions. To the extent the Minister is unavailable, we (the SMU) would make ourselves available to meet John along with John McCarthy from the economics division to give him a sense of the current investment case for Ireland.
