^{2,3} These charges refer to two pension payments incorrectly charged to the Central Fund. A total of €12205.21 was recouped from the Superannuation and Retired Allowances Vote in 2016 and the balance recouped in 2017.

⁴ Pensions surrendered in 2016 may differ from that recorded in the Finance Account (Statement 1.2 under Other Receipts) due to the time-lag in the payover of voluntary pension deductions to the Exchequer.
